Service Terms and Conditions

These terms and conditions apply to the submittal of all comic books through Comic Book Certification Service LLC's ("CBCS,") by you, (the "Customer," "you," or "your,") described in the "Ordering" section of this submission form (collectively referred to as the "Services"):

1. CBCS grading and authenticity standards are fundamental to its concept of third-party grading. CBCS guarantees all comics submitted to it shall be graded in accordance with its stringent grading standards and procedures. CBCS guarantees this comic book has been inspected by a minimum of two graders and one finalizer. The assigned grade represents our subjective opinion. In the unlikely event of any clerical errors with respect to the description or grade of a comic book, the clerical error will be corrected at no charge. Certain books may receive a "pedigree" designation at CBCS's discretion and based on supplied information believed to be accurate by the grading staff. Books submitted to CBCS may be imaged and used by CBCS at any time.
2. The CBCS comic book protective case is designed to be tamper-evident and has other security features to discourage fraudulent use. Extremes in light, temperature, moisture, vibration, and other environmental conditions can contribute to the deterioration of a comic book sealed in a CBCS protective case. For maximum protection, CBCS recommends you keep your CBCS certified comic books in an immobile, dark, temperature and humidity-controlled area. The CBCS protective case is designed to open to allow for the proper removal of the comic book. However, OPENING THE PROTECTIVE CASE VOIDS all CBCS certifications, warranties and guarantees. To avoid damage to the book, extreme care in following the correct procedure for removal must be exercised. CBCS will not be financially responsible for damage that occurs to a book while not in our possession. If you are not familiar with the procedure for opening a CBCS protective case, you should contact a CBCS Customer Service representative, toll free at: 844-870-CBCS, for assistance.
3. A restoration and conservation check has been performed on books submitted for grading and encapsulation in accordance with our guidelines and procedures. Detected restoration and conservation is noted on the label. A good faith effort is made to detect restoration and conservation, but CBCS cannot and does not warrant this process or the results. If restoration or conservation is detected, restored, or conserved books will be assigned a descriptive "restored" or "conserved" label. If both restoration and conservation is detected, the label will note "restored" and will reflect both the restoration and conservation. CBCS does not assure market acceptance of the grade or restoration/conservation check.
4. CBCS utilizes Beckett Authentication Services (BAS) to verify and authenticate comic book creators' signatures as part of its Verified Signature Program (the "Program.") As part of the Program, BAS implements its standard authentication techniques on each signature submitted and provides an opinion from as to the authenticity of the autographed signature(s) on each comic book submitted to CBCS.
5. Beckett Authentication Service determination of the authenticity of a particular signature is based on the BAS Signature Authenticator's subjective opinion. By utilizing the Verified Signature Program, the customer releases CBCS and BAS from any and all liability which may arise based on any error made during the signature verification process or services, including but not limited to BAS authenticating a signature in error, or failing to authenticate a signature in error. The accuracy of signature verification is not guaranteed.
6. Customer acknowledges that knowingly submitting a comic book with a forged signature through the program amounts to fraud, and CBCS reserves all rights and remedies it may have to institute the appropriate legal action because of such conduct.
7. CBCS has the right in its sole discretion to reject any items submitted for services in cases where the submitted items do not comply with CBCS' then-current standards and procedures. CBCS has the right to raise the grading and pressing tier of a specific books based on the opinion of CBCS of actual fair market value. In the event of that occurrence the customer will be notified of billing change, and the customer will submit the difference in balance prior to CBCS Shipping.
8. CBCS offers guaranteed Turnaround Times on Express Services for grading and pressing. The guaranteed express service turn times varies, dependent on the grading and/or pressing service, and covers the period when the order is verified by the CBCS Dallas receiving department and entered into our system and payment in full is received, (Start date) until the submission is shipped (end date). Super express services cover a 24-hour period starting from the time the Dallas receiving department verifies submission, to shipping on the next business day. The individual and specific turn times are listed on the CBCS website in days and are subject to change. CBCS considers days to mean business days when the facility is open for business, excluding, weekends, observed holidays, On-Site grading events, and days when the facility is closed for whatever reason deemed necessary by CBCS, including weather and other reasons as deemed necessary by CBCS. If payment is delayed for any reason, the start date for the guaranteed turnaround time officially starts when the invoice is officially moved from Billing to Pre-Grade.
9. CBCS will use reasonable care with respect to items submitted to it for Services. However, in the event CBCS determines an item was lost or damaged while in CBCS' possession, CBCS will compensate Customer based upon CBCS' good faith determination of the fair market value of the item AND ONLY IF the customer has requested insurance for their submissions. Coverage is based on CBCS determination of reliable current market information. The amount of the compensation will not necessarily be based upon, but in no event will exceed, Customer's stated insured value of the item set forth in this Submission Form.
10. CBCS offers customers the ability opt out of return shipping insurance. Customers who choose not to use CBCS supplied insurance on return submission shipments acknowledge that CBCS shall not in any event be liable for economic loss in any form such as indirect or consequential loss of, or damage during shipping transit and only FMV as determined by CBCS if no FMV insurance value or coverage estimates are provided by the customer.
11. Customer must inspect all items immediately upon receipt from CBCS. CBCS shall have no liability for any damage or errors unless reported to CBCS within five (5) days of Customer's receipt of the items.
12. Customer shall complete all submission information on the Submission Form, and package and ship all items, in accordance with the instructions on the Submission Form. Submissions shall not exceed 100 books per each submission order. Customer represents and warrants to CBCS the insured value set forth on the Submission Form represents Customer's good faith belief as to the market value of the item. Failure to fill out the submission form completely and accurately may result in delayed turnaround times or additional charges for any regular submission or express submission.
13. EXCEPT FOR ANY EXPRESS WARRANTIES SET FORTH IN THESE TERMS AND CONDITIONS, CBCS DISCLAIMS ANY AND ALL WARRANTIES, EXPRESS OR IMPLIED, REGARDING CBCS AND/OR THE SERVICES, INCLUDING BUT NOT LIMITED TO THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THE MAXIMUM AGGREGATE LIABILITY THAT CBCS SHALL HAVE TO THE CUSTOMER, OR ANY THIRD PARTY FOR WHOM THE CUSTOMER MAY BE ACTING, ARISING FROM ANY CAUSE, ACT, OMISSION OR OTHER CIRCUMSTANCE, SHALL IN NO EVENT EXCEED THE SERVICES FEE OR FEES PAID BY THE CUSTOMER FOR THE SERVICES ORDERED PURSUANT TO THIS SUBMISSION FORM. IN NO EVENT SHALL CBCS OR ANY OF ITS AFFILIATES, OR ANY OF ITS OR THEIR RESPECTIVE EMPLOYEES, OFFICERS, DIRECTORS OR AGENTS, BE LIABLE TO CUSTOMER OR ANY OTHER PARTY FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL OR EXEMPLARY DAMAGES, AND IN NO EVENT SHALL THE AGGREGATE LIABILITY OF CBCS, ITS AFFILIATES, AND ANY OF ITS OR THEIR RESPECTIVE EMPLOYEES, OFFICERS, DIRECTORS OR AGENTS, EXCEED THE FEES PAID OR PAYABLE TO CBCS FOR THE SERVICES.
14. CBCS compiles data regarding, and makes digital images of, items submitted for Services. In partial consideration for the performance of Services by CBCS pursuant to this Submission Form, Customer hereby authorizes CBCS to compile such data and make such images and agrees that CBCS shall have an irrevocable, non-exclusive, perpetual, unlimited, royalty-free right and license to use and commercialize such data and images for any purpose
15. Customer agrees the laws of Texas, without regard to its choice of law principles, shall apply to transactions and/or disputes between CBCS, CBCS Pressing and Customer. Customer further agrees the exclusive jurisdiction and venue for any dispute between CBCS or CBCS Pressing and Customer shall be in the state or federal courts located in, or serving, Dallas County, Texas.
